They identify a Veteran as one who must have served at least one (1) day of active duty. To qualify you must have had any discharge other than dishonorable.

They have homeless prevention and support housing programs in NJ and PA. They can assist getting a Veteran into transitional housing as well as permanent housing for both men and woman. They will work to link up the Veteran with other veteran services that may be available.

#### **Foreclosures**

The NAACP conducts a series of FREE workshops around northern NJ to address this issue. These workshops are particularly important to Vets who are less familiar with current laws or their legal rights.

There is a great deal of misleading information people are told from their banks; many times the banks are just bluffing people. If you ask for particular records chances are good they may not have them.

Many times a home mortgage is sold from lender to lender. As a result the first lender still may have a lien on your property even if they have long gone out of business. If so it may take over a year for you to clear up the title to your home. Until you do so you would not be able to sell it.

Topics they discuss apply to all homes through NJ. If you need additional help after a seminar they will work with you on an individual basis to lead you through the processes.

If your property is under water (your mortgage is greater than the actual value of your home) they can assist you / direct you to lenders that will restructure your loan / monthly payments.

Over the last several years NJ has passed several laws reversing 120 years of consumer protection against foreclosures. One day in the Star Ledger there were 32 pages of Sheriff's Sales of Homes that had been foreclosed on.

The NAACP can also assist with **Bankruptcy**.

#### **NJ State Income Tax Exclusions**

US military pension and survivor's benefit payments are not taxable for New Jersey gross income tax purposes, regardless of the recipient's age or disability status.

## **NJ Property Tax Deduction**

An annual \$250 veteran's property tax deduction requires: citizenship, state residency, active wartime service in the US armed forces, honorable discharge, property ownership, and the timely completion of an application. The surviving spouses qualifies if all criteria were met. Eligibility for the deduction is established as of October 1 of the pretax year. The application can be filed at the local tax assessor's office with appropriate documentation.

## NJ Property Tax Exemption

Eligibility for Veterans who meet all the following criteria:

- Served during a specific wartime.
- Received an honorable discharge or under honorable conditions.
- Rated 100% permanent service-connected disabled by the VA. The 100% rating cannot be temporary or as a result of hospitalization, surgery or recuperation

## NJ Catastrophic Entitlement

Eligible Veterans or their surviving spouses receive a monthly entitlement of \$62.50

Available to Vets who have injuries resulting from wartime service in one of the following catastrophic disability resulting in 100% rating:

- loss of sight
- amputation of both hands
- both feet or one hand and one foot
- hemiplegia and permanent paralysis of one leg and one arm on either side of the body
- paraplegia and permanent paralysis of both legs and lower parts of the body
- osteochondritis and permanent loss of use of both legs
- multiple sclerosis
- the loss of use of both feet or both legs
- quadriplegic

# Veteran Preference and Pension Status Veteran Preference for Hiring in NJ Civil Service

The NJ Department of Military and Veterans Affairs is the agency to determine Veteran preferences for hiring in NJ civil service and Veteran status, for NJ civil service pension plans.

War period Veterans who pass state civil service examinations are given absolute preferences over those who were not Veterans. When applying for state, county, municipal employment absolute preference is not extended to promotions.

### **Veterans Status for Civil Service and Pension Plans**

A pension is available to qualified Veterans. To qualifying a Veteran must apply for Veterans status for the civil service pension plans after employment and must be in active employment until the effective date of retirement. Veteran's benefits cannot be deferred and the Vet must meet all the requirements to qualify

## **Employment or Promotion**

Any individual who served and has been awarded the Medal of Honor, the Distinguished Service Cross, Air Force Cross or Navy Cross while a resident of the state shall be appointed or promoted without complying with the rules the Merit System Board.

The appointing authority the individual applies for appointment or promotion shall at its discretion appoint or promote that person. A person who qualifies under this section shall not be limited to only one appointment or promotion

OCO believes in the inherent worth of every homeless man, woman and child and provides emergency supplies and survival gear to the most vulnerable members of our homeless communities wherever they encounter them. They bring their care to all homeless people without regard of religious affiliation, ethnic heritage or state of life.

OCO particularly seeks out Veterans of our military services, many of whom, because of the traumas they endured in service to our nation, face acute Post Traumatic Stress Disorder (PTSD) and other chronic illnesses of body, mind and spirit, and are represented among the highest percentage of homeless people in the USA.

## Operation Chillout con't.

Their philosophy is "We welcome all strangers as we would a guest to our family and observe no borders – no barriers" in our work. OCO practices humility, charity and the "spiritual and corporal works of mercy" to alleviate the suffering of the poor and homeless in our communities and throughout the world."

OCO is an all-volunteer coalition dedicated to relieving the suffering caused by the crisis of homelessness. There are no paid staff or salaried executives, there are no headquarters' building; their outreach work conducted in the field.

Their research shows that one out of every five homeless persons they encounter is a military Veteran. Many face PTSD and chronic illness of body mind and spirit. They conduct outreach missions to find homeless Vets and provide situation assessment, crisis intervention, advocacy and referral services for housing, medical and social services. They distribute concrete, basic supplies necessary for temporary survival while housing options are considered on a person by person basis.

Their *Rapid Response Outreach Team* is able to provide emergency services 24 / 7 /365 @ 609-619-0861.

The programs 4 Rs are:

- 1. Respond to all calls and referrals made to their hotline (OCO is an option on NJ-211 Information ).
- 1. Rescue all homeless Veterans in need after emergency crisis intervention and assessment.
- 2. Rehabilitation is arranged with appropriate service providers for each person's needs.
- 3. Return Veterans to their communities to pursue meaningful lives.

OCO conducts conduct two annual seasonal outreach campaigns.

- In the winter they prepare back packs for homeless men and women filled with <u>NEW</u> warm clothing, toiletries, survival gear, sleeping bags and information regarding local resources.
- In the summer they provide cases of bottled water, t-shirts and baseball caps.
   These items are collected and delivered free to various locations where homeless people gather: food pantries, soup kitchens, temporary shelters, abandoned buildings, parks and alleyways.

The county provides transportation for Veterans in Sussex County to the three VA Medical Hospitals and one clinic on a regular scheduled basis:

- Lyons: most Thursdays, arrivals at 10 AM, departure at 12:30 PM
- East Orange: most Thursdays, Arrival at 10 AM, departure at Noon
- Castle Point (NY): on Thursdays but call for dates
- Morris Plains Clinic: Monday, Wednesday & Friday, call for times

They suggest you make your appointment at least a week or two weeks in advance

The critical issue is that medical appointments at the hospitals or clinics must be made at a specific time of the day (BEST ABOUT 10:15 AM) so that the veteran can conclude their visit by the time the transportation has to return back to Sussex County.

It is always recommended that the veteran make the earliest possible appointment at the clinic or hospital. The transportation cannot wait beyond its departure time. Unfortunately, not every special service is available on the days that they travel to the particular hospitals.

They will pick the veteran up at their home (outside). The night before the pickup they will call you to let you know what time they will pick you up at your home. They will assist the veteran from their home to the bus or onto the bus if necessary. The Veterans has to be ambulatory. If not, the veteran may bring a companion to assist them.

This is a free service for Veterans but they do accept donations.

They all also have a city bus that runs between the towns of Sussex, Hamburg, Franklyn, Ogdensburg and Newton on a regular schedule and makes regular stops; the cost is \$1.00 each way.

This is a relatively new program for New Jersey started in 2012. It has been in 20 states since 2008. In New Jersey there are currently 15 foster care homes. This is not the same as the Homeless program.

The program came about:

- as an alternative to a nursing home for a Vet
- when a veteran can no longer live with their family
- when they no longer can take care of themselves

The receiving family with whom the Veteran lives with receives between \$2000 to \$4000 compensation depending upon the Veteran's disability. The average amount is currently about \$2800. The amount is based upon the specific needs of that veteran. The receiving family accepts the Veteran into their home, just as they would a foster child. The Veteran becomes part of the family.

There also is a support team from the VA that visits the Veteran on a regular basis. Some of the members of this team include a dietitian, medical doctor, nurse practitioner, physical therapist or psychologist and other support personnel.

The minimum criteria of the program are:

- the Veteran will receive their own private room with a minimum of 100 ft.2
- On occasion when a veteran shares a room, the room size must be at least 180 ft<sup>2</sup>
- The caregiver must live in the home with the Veteran.
- It is a 24 hour supervised care

- The caregiver is responsible for assisting the Veteran in whatever their particular needs may be, such as assistance dressing, providing their medication at the appropriate time, etc.
- The Veteran receives three meals a day plus snacks, laundry service and all other services that one would expect to receive in their own home.

# The keys to the program are:

- The host family must be the ones providing the care to the Veteran
- The Veteran is to be a member of the family
- Responsibility for caring for the Veteran cannot be assigned to someone living outside the home
- In order to qualify for the program, the Veteran must have some type of disability and cannot care for himself.

The VA provides biannual care giving training sessions for the host family. In some cases a Veteran can bring their spouse or an additional family member with them into the program.

Every effort is made to match the interest of the Veteran to similar interest of the family, whether it be enjoying the outdoors, or attending a particular religious service. For the most part the Veteran improves both mentally and physically while in the program. A Veteran of any age can enter the program as long as they qualify.

The Rural Health Program is a home-based primary care program. It operates in Hunterdon, Warren, Sussex and as far south as Ocean County.

The care team involves a physician, nurse practitioner, registered nurse, clinical social worker, physical therapist, registered dietitian, pharmacist and a clinical psychologist.

They visit the Vet in their home for routine exams and provide those services usually provided in a clinic by their primary care doctor. Costs are typically the same as those of the outpatient clinics.

#### Services such as:

- Blood work
- Vaccine administration
- Referrals to specialist
- Providing medical supplies and equipment

The Veteran must be in the VA health care system and be recommended into the program by their primary care physician. The general age range of those receiving this care tends to be typically from the Vietnam era veterans (70ish) and older.

If a Veteran needs specialized care either at Lyons or East Orange they would be required to make that trip.

The Home Base Program and Rural Health Program are in reality one program provided similar care to the Veteran in their home environment.

## **Veterans Services**

The eligibility criteria to register for VA services have changed over the years. Prior to 1980 if you served just one day of active duty and received an honorable discharge, you were eligible. Since 1980 you needed to have served two years of active duty with an honorable discharge.

There are some variations to that rule, some veterans are automatically eligible:

- Vietnam "Boots on the Ground" Veterans
- Purple Heart Veterans
- Disabled Veterans
- Ex-POWs

There are other considerations to determine eligibility today. A Veteran's income in Sussex / Warren Counties needs to be below \$46 – 47, 000. Add another \$7000 for a spouse. Once in the VA system you remain in regardless of your future income. Assets that you may have do not play a role into your acceptance or denial into the program.

Iraq and Afghanistan Veterans had / have five years to apply to be automatically eligible. After the five-year period they have to apply using the financial guideline standards as outlined above.

All Vets should apply to qualify today since admission standards for eligibility into the VA system can change at any time. After the new presidential elections eligibility requirements could change. For example, they may only accept veterans who were disabled during their tour of duty.

You can **apply online but it is not recommended** since your application can be lost. The best way for someone to register is to take their DD 214 up to the Eligibility Office at Lyons or East Orange and complete the application process. You should be approved before you leave the building.

# US Department of VA (Veteran Affairs) con't.

Once accepted into the program, in order to receive benefits you need to have a VA Primary Care Physician. All appointments and special treatment is coordinated through your primary care physician.

Some of the most popular benefits that Veterans receive today are free glasses and hearing aids. One of the more difficult treatments to be approved for is dental care. The veteran usually needs to be 100% disabled in order to be entitled to this service.

However there are affordable dental insurance plans that are available to Veterans through MetLife and Delta Dental. There is also another affordable Dental Care Program without monthly premiums through Zufall Health which has dental (and medical) offices in Hackettstown, Newton and other locations in northern NJ.

A benefit of the VA medical program is that there are no monthly premiums. Most Veterans pay for their medications. Cost run from \$8 to \$9 per 30 day supply for a medication. Also in many cases there is a co-pay of \$15 per visit to your primary care physician and \$50 to see a specialist. By that it means if you see the specialist several times regarding the same condition you pay a one-time charge of \$50. There are many Veterans who due to service related injuries do not pay for any services. Also any Veteran who is 100% disabled does not pay for services.

## **Medical Records, VA**

As part of the VA's promise to safeguard the private information of Veterans policies and procedures have been created. The process below applies when a Vet request to view their medical (history) chart.

- ✓ You would need to inform any health care team member you wish to review your medical chart with your Health Care Provider
- √ Identify which medical records you want to review
- ✓ If a full review of your entire medical chart is requested an appointment must be made. Thirty minutes are allocated for this non-billable appointment.
- ✓ Your provider will not review your medical history with anyone other than you.
- ✓ You CAN NOT receive a copy of your medical records during a review
- √ To receive a copy of your complete medical records you need to fill out a VA form 10-5345A, "An Individual's Request for a Copy of Their Own Health Information".
- √ All mental health questions must be referred to your Mental Health Provider.

The Professionals at the VCL are specially trained and experienced in helping Veterans of all ages and circumstances, from Vets coping with mental health issues that were never addressed to recent Vets struggling with relationships or the transition back to civilian life.

# **Current Presumptive (Ilnesses)**

Below are the categories of Veteran who have presumptive established.

# **Recently Separated**

If a Veteran is diagnosed with chronic diseases, such as arthritis, diabetes or hypertension, within one year of their release from active duty, the VA will presume that the condition originated during military service.

# Agent Orange (Registry) 800-749-8387

Agent Orange was a defoliate used in Vietnam. Many troops who served in Vietnam suffer today from the array of symptoms that today are recognizing as the result of Agent Orange.

If a Veteran has any of the following conditions, the VA will presume that the condition was caused by exposure to Agent Orange.

- Hodgkin's Disease
- Multiple Myeloma
- Non-Hodgkin's Lymphoma

- Acute and Subacute Peripheral Neuropathy
- Prostate cancer
- Respiratory Cancers
- Soft-Tissue Sarcoma
- Diabetes Mellitus (Type II)
- Spina Bifida (for the children of Vietnam Veterans)
- B Cell Leukemia, such as Hairy Cell Leukemia
- Parkinson's Disease
- Ischemic Heart Disease

In addition to the current list there are other symptoms and illnesses that can also be related to Agent Orange. Many illnesses even though not listed on the approved list of illnesses are related or connected to those items on the list.

If you were exposed to Agent Orange while overseas and suffer from any disability it is quite possible that that your disability can be linked to it. Should you have any doubt, contact the **Agent Orange (Registry) 800-749-8387**

## **MyHealtheVet**

Is a portal that provided a secure online setting where Veterans may view and manage their own personal health records, access medical relevant and factual health information, perform health reviews and use electronic services such as prescription refills. It gives Vets an active role in their health care planning.

This is another program where a Vet's spouse can be eligible for free VA benefits and the children up to 21 years old can also receive free medical treatment.

# Military Sexual Trauma (MST)

Military Sexual Trauma is a term the VA uses to refer to sexual assaults or repeated, threatening sexual harassment occurring during a Vet's military service. Eligibility has been extended to Reservist and National Guard members participating in weekend drills.

# The VA provides:

- free outpatient, inpatient and residential services to help a Vet recover from MST
- Without a limit to the duration of the care.
- Care is provided at every VA health care facility
- Each VA Medical Center has a MSY Coordinator

There are also in residential and inpatient care plans for those who need more intense treatment and support.

To receive free treatment related to MST:

- The Vet does not need a VA service connected disability
- Does not need to have reported the incident when it happened or have any documentation that it occurred.
- No length of service requirements
- Some Vets may qualify for free treatment even though they do not qualify for other VA benefits

VA provides free readjustment counseling and outreach services to Vets who have served in a theatre of operations (combat zone), through community based counseling centers, called Vet Centers. Services are also available for their family's members regarding military related issues.

## Women's Health

Female Veterans are potentially eligible to receive care provided in their local community when authorized by the VA. The decision to use such care is left to the VA facility providing your care and is usually granted only when the VA cannot provide required services or because of geographic inaccessibility. VA services offered to women Vets include:

- √ Women's gender specific health
- √ Screening and disease prevention
- √ Routine gynecologic services

# **Town Hall Meetings**

The VA holds town hall style meetings; all Veterans are strongly encouraged to attend. At these programs there are clinicians who can immediately process any claims for a Vet.

A Vet needs to see a VSO in order to file a claim for a service connected disability. The VSO concentrates his activity on claims and not healthcare. Always deal with an accredited Veteran Service Officer. Several VFWs and AM Legions posts have members who are VSO.

A service-connected disability is anything that is caused while on active duty. Before coming to VSO for assistance the Vet needs to bring his DD 214 form.

If you're in the National Guard you're not on active duty, unless you are deployed, if you're injured during training or injured while traveling to training.

When you have a claim, you have to demonstrate continuity of the injury you are claiming. It must be reasonable that nothing else outside of your service could have caused it. By that it is meant if you were injured while on active service your injury or disability has to be continued to this day.

### Veteran Service Officer con't.

For example if you suffer a hearing loss because you were in artillery and did not have ear plugs and since you left the military you worked as an accountant and your hearing is still poor there is a good possibility your hearing loss was service related.

A fully developed claim can take time to submit and resolve. The goal by the VA is 127 days for approval or disapproval. If you wish to file a claim the form is very comprehensive. You will also send a DBQ (disability benefit questionnaire) which is used by the VA to help evaluate the claim.

It is best for you have a doctor who is outside the VA evaluate your condition and provide their conclusion that your condition is a result of an event that occurred during your time of service. **It is important** that they indicate how they reached this conclusion or rational.

Some claims can take several years to resolve. If the claim is not done properly with solid back-up: it can bounce around as "denied" for several years until it may be finally approved. Once you submit a claim you need not submitted a second time while it is being processed.

Your claim may be approved quickly if completed properly and you have a thorough evaluation, a solid rationale and all other pertinent information. Therefore it is best to do it correctly and thoroughly the first time around.

Award amounts are in even 10%s, an award of 20% is approximately \$258 a month, 60% is \$1041. It depends upon your percentage of disability, which is how much your disability prevents you from working. Like everything in life this is subject to change.

If your claim is denied you have one year from the decision date to file an appeal.

## The Veteran's Pension

This program is for any Veteran in need whose income is less than \$12,600 per year. The VA will raise it up to that amount.

Program options are:

- The Veteran needs to have at least one day of wartime service.
- Pensions are also available to the Veteran's widow.
- There are benefits offered to the spouse of any Veteran who died service related condition.
- Lung cancer or Agent Orange are automatic conditions.
- There are compensations for service connected deaths.

Veteran's Haven North is a 24 / 7 facilities run by the NJ State Department of Military and Veterans Affairs. They have rolling vacancies in two programs (emergency shelter and transitional housing) and are continually conducting interviews for new residents.

It is a fully self-contained facility having a library, gym, full kitchen, game room and social activities.

VHN has a team of social workers and vocational counselors and a nurse. It is licensed as a boarding home, not a clinical healthcare facility. For the most part Veterans receive their treatments from one of the two area VA Hospitals. Transportation is provided. Only if the Veteran is involved in the VA Rural Health program is healthcare provided within the facility.

The facility concentrates on what caused the Vet to become homeless and help stabilize the situation. Their goal is to return the Veteran back into the community through permanent housing or some type of transitional housing plan.

VHN works with Veterans to stabilize any addiction or health issue that leads their families to tell them they cannot stay at home. Their goal is the reunification of the family. They have a separate wing for the women.

They only serve Veterans and cannot serve spouses or children (unless they are also Veterans). Any woman coming into the facility that has children must make separate arrangements for the children. The children would not be permitted to use the facility.

They provide two types of services:

# The Transitional Housing Program

- Is a two-year tradition transitional housing program
- Rent is income-based. Rent is 30% of income (after certain allowable deductions) never to exceed \$300.
- \*\*\*It is not limited to New Jersey Veterans\*\*\*
- Candidates come from as far away as California.
- To enter into the program, you must first prove you are an honorably discharged Veteran and pass a drug and alcohol test.

# The Shield Program.

The liaison for the program is Scott Sussman: 908-647-0180 x4425.

The program is an emergency shelter and treatment program. Lyons conducts the primary assessment and screening not VHN. The VA hospital in Lyons has a bed allotment at VHN enabling them to place a veteran who is in need.

The Shield program has a shorter length of stay: 90 to 180 days. The goal of the program is to help Veterans rectify the situation that has caused their homelessness so it will not continue to negatively impact them. Ideally Veterans are returning to permanent housing within the community.

If permanent housing is not an option and after 180 days if there obviously are some serious issues that need to be worked out for the Veterans they can be assisted at higher levels of care (substance abuse residential treatment, PTSD residential treatment, other transitional housing programs, etc.).

The Veteran coming into this program can still fail a drug / alcohol screening test as long as they state a desire to become clean / sober; however, they must then pass another screening reasonably soon after arrival.

There is no charge to the Veterans in this program as the VA covers the cost.

## Overview:

The approximately 130 members of this chapter are among the most well versed Veteran advisers in northern NJ. There are few Veteran related issues that this group is not up to date on and involved in. Their knowledge goes well beyond the few topics mentioned here.

# **Veteran's Memorial Cemetery of Northern New Jersey**

It is the only cemetery owned and operated by Veterans in the country. It has recently opened (2016) and follows all the rules and regulations of the other state and federal cemeteries.

Cemetery planning began in 2008 and was finally approved in 2015 as a not-for-profit Veterans Cemetery. The cemetery cost \$1.00 to buy the land.

Based upon state regulation the cost of a burial is \$650. Out of this amount 15% goes into a fund for perpetual maintenance of the cemetery. The headstones are government issued and are free.

The cemetery is approximately 60 acres, of which 25 to 30 acres will be used for burials; that allocated enough space for 14,000 to 18,000 Veterans and their spouse's plots. The remainder acres will be for greenery and trees.

# Camp Lejeune Water Contamination Camp Lejeune Family Member Program (CLFMP)

From August 1, 1953 to December 31, 1987 the water wells at the Marine Camp Lejeune, NC were contaminated. During this time Veterans and their families who were living at the Camp were potentially exposed to drinking water contaminated with industrial solvents, benzene and other chemicals.

On August 6, 2012 the Honoring America's Veterans and Caring for Camp Lejeune Families Act of 2012 was signed into law. This law, now Public Law 112-154 requires the VA to provide health care to Veterans who served on active duty at Camp Lejeune and to reimburse eligible Camp Lejeune Family Members (CLFM) for health cost related to one or more of the following illnesses or medical conditions:

\* Bladder cancer

\* Esophageal cancer

\* Hepatic steatosis

\* Leukemia

\* Miscarriage

\* Brest cancer

\* Female infertility

\* Kidney cancer

\* Lung cancer

\* Multiple myeloma

\* Myelodysplastic syndromes \* Neurobehavioral effects

\* Non-Hodgkin's lymphoma \* Rental toxicity

There is a push to have the VA provide compensation similar to what is being offered Veterans suffering from Agent Orange. It is in the works, but it could take more than a year for the program to work its way through all the necessary channels. Right now the VA is just taking care of all the health concerns, treatments and doctors' bills.

Anyone who was on the base between these years and believes they may have been exposed is encouraged to file a claim with the VA. The VA said that at this time, the claim may be denied, but they will put it aside and hold onto it until the new legislation comes through and then they will review the claim again

## **Blue Water Contamination**

This hazard pertains to Navy ships. If your ship was tied up or sailed in the waters of Vietnam you could be entitled to the same benefits of those soldiers affected by Agent Orange.

Sailors may have been contaminated by the vessel taking on water in Vietnam running it through the ships purification systems, which was unable to remove all toxicants such as Agent Orange, then using this still contaminated water for bathing, cooking and general drinking.

If one crew member of your vessel has filed a claim then all of the members on that vessel also qualify to file a claim.

## **Brown Water Contamination**

It is illnesses that pertain to crews of boats such as PT boats that went up the rivers in and around Vietnam. The crews now have similar illness to those exposed to Agent Orange.

# Agent Orange (Registry) 800-749-8387

Agent Orange was a defoliate used in Vietnam. Many troops who served in Vietnam suffer today from the array of symptoms that today are recognizing as the result of Agent Orange.

If a Veteran has any of the following conditions, the VA will presume that the condition was caused by exposure to Agent Orange.

- Hodgkin's Disease
- Multiple Myeloma
- Non-Hodgkin's Lymphoma
- Cute and Subacute Peripheral Neuropathy
- Prostate cancer
- Respiratory Cancers
- Soft-Tissue Sarcoma
- Diabetes Mellitus (Type II)
- Spina Bifida (for the children of Vietnam Veterans)
- B Cell Leukemia, such as Hairy Cell Leukemia
- Parkinson's Disease
- Ischemic Heart Disease

In addition to the current list there are other symptoms and illnesses that can also be related to Agent Orange. Many illnesses even though not listed on the approved list of illnesses are related or connected to those items on the list.

If you were exposed to Agent Orange while overseas and suffer from any disability it is quite possible that that your disability can be linked to it. Should you have any doubt, contact the Agent Orange (Registry) 800-749-8387

  - o From Allentown there is a VA shuttle to the Wilkes Barre –Scranton Hospital. The Vet will need to confirm this transportation schedule with the VA
- Also to all medical / dental appointments within the county such as the Zufall Health Clinic in Hackettstown.

## **Demand Response**

The County receives a small subsidy from the VA for county Vet's transportation. They can run two trips for Veterans each week to either the hospitals, clinics or for an in county doctor's appointments. So call immediately when you want to make a transportation reservation. First come first two served.

They will take several Vets to the same location, such as Lyons, on the same day and time.

They will pick the Veteran up at their home (outside). Curb to curb service. They will assist the Veteran onto the bus if necessary. The Veterans has to be ambulatory. Wheelchair transportation is available but mention this when making your reservation. A Veteran may bring a companion to assist them.

# Warren County's Transportation Program con't

A Vet needs to be honorably discharged, meet income guidelines or live in rural areas in the county. FIRST TIME Vet users will be asked to show either their DD 214 or a letter confirming their VA appointment.

Also required info of first time users include:

First and last name Date of birth

Home address Telephone number Household income Medicaid eligibility

Special Instructions Emergency contact and phone number

Some of this information is required by the funding organizations

The transportation usually arrives at the VA facilities as early as 9 AM and depart as late as 2:30 PM. Drop off and pick up is always at the same location

This is a free service for Veterans but they do accept donations.
